



Environmental Management in Busoga

The national environmental management Authority (NEMA) is the principal agency responsible for the management of the environment in Uganda and it coordinates, monitors and supervises all the activities in this field. It aims at being an efficient and self sustaining agency, ensuring that people in Uganda most especially Busoga live in a clean, healthy, productive and sustainable environment.

While NEMA is responsible for monitoring, planning and coordination of environmental matters, implementation is in the liaison units within each of the line ministries responsible for integrating environmental activities within the mandate of the ministry.
